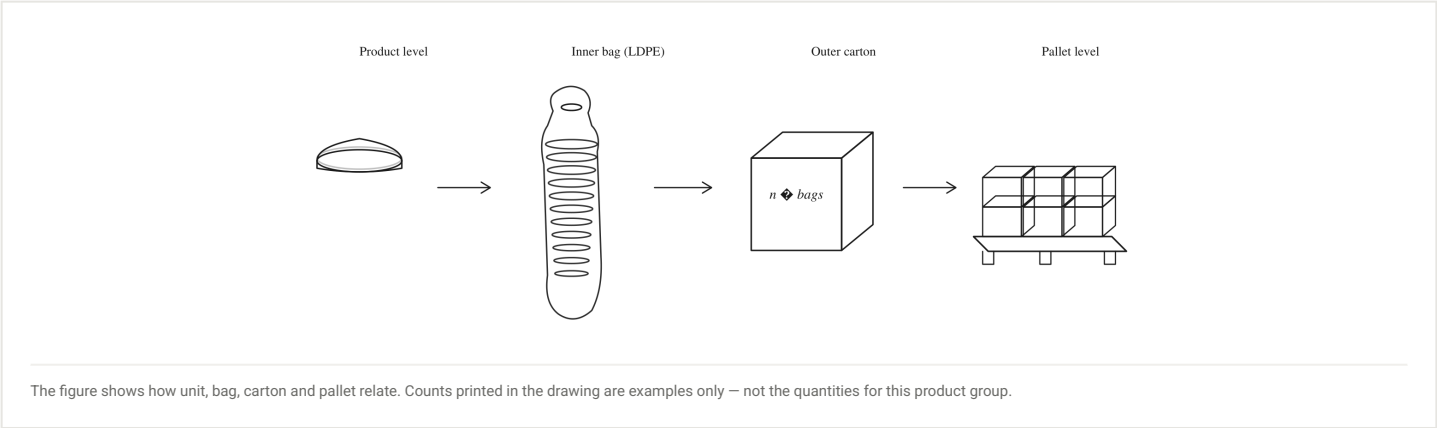
06EPR PACKAGING HIERARCHY
